CONTRACT

THIS CONTRACT, made and entered into this 20th day of October, 1993, by and between the BROWN COUNTY CONVENTION AND VISITORS COMMISSION, hereinafter referred to as the "Commission," and the NASHVILLE/BROWN COUNTY CONVENTION AND VISITORS BUREAU, INC., hereinafter referred to as the "Bureau."

WHEREAS, pursuant to Public Law 92 of the Indiana Acts of 1977, the Commission desires to contract with an Indiana not-for-profit corporation for the purpose of promotion and encouragement of conventions, trade shows, and visitors of Brown County; and

WHEREAS, the Bureau is an Indiana not-for-profit corporation with expertise in the promotion and encouragement of tourism, conventions, trade shows, and visitors;

NOW, THEREFORE, it is agreed by the Commission and the Bureau as follows:

1. This Contract shall commence on the 1st day of January, 1994 and shall terminate on the 31st day of December, 1996, unless extended by mutual agreement of the parties hereto.

2. The Commission shall compensate the Bureau for the amount annually budgeted by the Bureau and approved by the Commission for the promotion and encouragement of conventions, trade shows, and visitors in Brown County, Indiana; PROVIDED that said payment shall be subject to appropriation of said sum by the Brown County Council; and PROVIDED further that said payment shall not exceed the funds received from the County of Brown for said purpose.

3. The Bureau shall provide meeting notices, oral reports, and financial reports to the Commission at the regularly scheduled meetings. Said reports shall include progress made by the Bureau and a Financial Statement of expenditures made to perform this Contract.

4. Payment by the Commission shall be made quarterly on the 1st day of January, 1994, and each quarter thereafter through the duration until the same is received from the County of Brown and appropriated by the Brown County Council.

5. The operating records of the Bureau relating to the Bureau performances of this Contract shall be accessible to the Commission for review during normal business hour of the Bureau upon sufficient notice to the Bureau to permit the Bureau to make said records available for the purpose of review.

6. The Bureau, as an independent contractor, shall determine the details of the Bureau's performance of this Contract but shall perform the same consistent with the Commission's duties under Indiana Code 6-9-14 and Ordinance No. 1984-1 of Brown County, Indiana.
